Jay S. motion we nominate a courthouse site from the four outlined by the city, Toni motion to add the Hudson Site, none were in favor, motion did not pass. members of the board are encouraged to share any information individually regarding opinions/thoughts on Courthouse Site Selection.
- Sidewalks completed at SW8th way/SW 9th St/SW8th Ave , along with Radar sign in place on SW 9th Ave.
- Character areas and transit zones are moving forward to Planning & Zoning Board, next meeting will be coming up in September 16; please look out for that

- Modification to site plans developers continue to change plans after approved (aesthetics and otherwise); shared interest in having us approach commissioner to have these items be received; concerns on the side of the developer were discussed; concerns with making sure that the development is reviewed is what is comes to the city; Janet will pull together with the information and reach out to the city on behalf of TRCA communicating interest in knowing about any site plan changes so that community leaders/board members can reach out Commissioners as appropriate and ask for the items to be called up for review.
- TRCA General Meeting will be held virtually on Aug 27th with next BOD meeting on 10th Sept. Janet motioned a request for us to get our own TRCA zoom account, Brucie second, all were in favor, Allison to work obtaining this account.
